EU activities

Last April ΕIJ Commission launched a proposal for reviewing the directive on heavyweight vehicles. ERMCO and its Members are playing an active role to improve the legislation current weight limits. The target is to raise from 32 to 35 tons current limit with the obvious benefits not only for the competitiveness of the industry but also for the environment. Our activity is now addressed to the EU Parliament, which will vote on this issue in April 2014.



Safe concrete pumping

A Code of Practice for the Safe Use of Concrete Pumps has been prepared by the British Concrete Pumping Interest Group (BCPIG) in collaboration with the UK Health & Safety Executive to give advice on the safe use of concrete pumps. The Code represents good practice well beyond the minimum requirements to comply with the law. It is available as a free download - click (here)

New use for recycled concrete

Concerns for sustainability are increasing the pressure to re-use demolished concrete. In many countries most of it is used for road base; but in a number of cases it is used for new concrete. Specificiers and architects may ask for a certain proportion of recycled aggregate, but readymix producers may find that they cannot find a reliable source, or that costs price it out of the market, or that this option has no effectiveness in terms of sustainability. From Denmark we have news of a new potential use for environmental purposes – recycled concrete used as a filter to trap excess phosphorus in lakes and rivers. Read more (here).


EU Commission sees growth prospects for SMEs

The European readymix sector (ERMCO Members), with 6.972 plants employing 50.762 people (average of 7.3 workers/plant) and 1358 companies and an average of 37,3 workers/company, is dominated by SMEs. The European Commission 2012/2013 Annual Report on European SMEs states that 2013 is expected to be the first year since 2008 with an increase both in total employment and added


