Let's work together and hope the actual situation will come to an end soon! ERMCO Staff


# **New EU Industrial Strategy**

## Regulation 561/2006 on Driving Times and Rest Period

ERMCO is pleased with the decision of the European Parliament and Council taken on December 2019 to allow national exemptions for the construction sector under article 13, and to include an extension to the delivery of "ready-mixed concrete". The final legal text will be discussed by the European Council and Parliament in a 2nd reading agreement with a finishing expected, depending on the evolution of the COVID pandemia, by the end of July or in September.

#### ECHA: CLP, ANNEX VIII

The EC has just cancelled the upcoming CARACAL physical Meeting (CLP and RECAH Session) planned on 31 March and 1 April. They are working now to set a video/internet conference to discuss x only 3 high priorities issues of the agenda:

- CLP: Annex VIII (workability amendment)
- REACH: Revocation of registration decisions
- REACH: Update on the activities in relation to the amendments of the REACH Annexes for nanoforms

The decision on the ERMCO amendment asking 2 UFIs (Unique Formula Identifiers) for ready mixed concrete is included in the agenda. We will keep you informed about the final decision.

# NEPSI KPIs Reporting 2020: Deadline Extension until 13 April 2020

The 2020 NEPSI Key Performance Indicators (KPIs) Reporting started on 22 January 2020 normally would

end on 22 March 2020. NEPSI has taken the decision to extend the reporting period and the *new deadline* is *13 April 2020*. The reporting of KPIs is done through the new IT system. Members of ERMCO Associations have the possibility to report.

The 2020 NEPSI KPIs Reporting is an important exercise to demonstrate the commitment of our industry to continuously reduce exposure to respirable crystalline silica (RCS): your valuable contribution to this important reporting system is crucial.
